1. General information

1.1. Aims of the course

The subject and its expected results respond to the following approaches and objectives:

As a whole, this module should take the student to the knowledge of relevant aspects of the management of socio-health centers, of ergonomic aspects of application in the field of elderly care and legal care for the elderly.

Within this module the subject The Socio-health Center: Integral Management aims to acquire relevant knowledge and capacity to apply in the professional context the new aspects of management in the residential environment.

The subject Gerontology Ergonomics in the elderly aims to acquire relevant knowledge and ability to apply in the professional context the new aspects of ergonomics, including assessments such as problem solving both at home and in the residential environment.

The subject Relative law in the elderly has a double objective, on the one hand to acquire relevant knowledge and ability to apply in the professional context the aspects of civil and criminal law that affect the elderly and on the other the ability to identify the different types of labor contracts that they can have in their professional practice.

These subject Objectives are linked to the following healthy Development Goals SDGs of the United Nations 2030 agenda (https://www.un.org/sustainabledevelopment/es), so that the acquisition of the subject learning outcomes provides training and competence to contribute to some extent to their achievement:

1.2. Context and importance of this course in the degree

- 2.- Identify, analyze and discuss the costs, profitability and balance Costs-Expenses, analyzing the organization of economic and human aspects.

In relation to the subject: "Gerontological Ergonomics".

- 1.-Identify, analyze and discuss the contributions of ergonomics in the gerontological and geriatric field.
- 2.-Identify, analyze and discuss the usefulness of anthropometric valuations in the greater.
- 3.-Analyze, discuss and make a proposal on resolution of external architectural barriers and domiciliary
- 4.- Design a space without architectural barriers.

In relation to the subject: "Law relative to the third age".

- 1.-Identify, analyze and discuss the contributions of the right in the gerontological and geriatric field.
- 2.- Identify, analyze and discuss the contributions of civil and criminal law in relation to the elderly.
- 3.-Analyze and discuss the possibilities of employment in relation to the care of the elderly.
- 4.-Analyze and discuss the contributions of labor law in relation to job opportunities in the care of the elderly.

2.3. Importance of learning goals

- The ability to apply the new aspects of management in the larger one involves improving the quality of life of both the elderly and the people in their environment. The acquisition of this makes our students improve their professional skills and their current and future users.
- The ability to apply the new aspects of ergonomics in the largest involves improving the physical and mental health of both the elderly and the people in their environment, and therefore also improves the living conditions of the elderly and of people with disabilities. that are related. The acquisition of this makes our students improve their professional skills and their current and future users.
- The capacity to apply the aspects of the right in the greater supposes to see the older person as subject of law and to identify the situations in which these can be violated. The acquisition of this makes our students improve their professional skills and the dignity of the users of the centers where they perform their professional activity. With respect to the ability to identify the different labor contracts that can be made will allow you to acquire capacity for the management of residential centers.

3. Assessment (1st and 2nd call)

3.1. Assessment tasks (description of tasks, marking system and assessment criteria)

The student must demonstrate that he has achieved the expected learning outcomes through the following assessment activities

Criteria and methods of evaluation:

Subject "The Socio-sanitary center: integral management".

Evaluation criteria:

- The student will be able to make innovative contributions in class, seminars and tutorials.
- The student unequivocally identifies the contributions of the management in socio-health care.
- The student will be able to analyze and discuss costs, profitability and cost-expense balance.
- The student will be able to prepare a budget for a social health center.

Evaluation methods:

They are shared by this subject and Gerontological Ergonomics

Attendance and participation in classes, seminars, guided study and tutorials.

Attennance: The reason for the evaluation of the attendance is to encourage the same since the learning is associated to the presence of the student in the different activities programmed by the teacher.

Participation: Mere assistance is not considered participation. Participating means contributing to the development of the different programmed activities in an intelligent and useful way for both the classmates and the teacher. The "erroneous" contributions will not be negatively assessed since they also help to clarify the difficult concepts.

This activity will accredit the achievement of learning outcomes 1, 2 and 3 and will be evaluated according to the following criteria and levels of demand:

The qualification of the attendance will be from 0 to 5 and will be 5% of the final grade of the subject. The qualification of the participation will be from 0 to 15 and will represent 15% of the final grade of the subject.

The overall grade of this attendance and participation will be from 0 to 20 and will represent 20% of the student's grade in the course. If the student does not attend any class of the modules, he/she will not be eligible for the maximum score neither of the modules nor of the course. In this section it will not be possible to increase the grade.

1. Resolution of practical cases. This activity will be developed in individual or interdisciplinary teams. (80%)

The resolution of practical assumptions is an active methodology proposed for the acquisition of professional skills. This method of learning supposes an approach to a style of learning more autonomous, more efficient and that allows the student the acquisition of those professional competences that will be more useful in their professional practice.

Interdisciplinary work is of great importance in the field of gerontology, since the elderly can benefit, both in health status and affects various pathologies, from the care of multiple professionals. The benefit that can be obtained from these teams is greater if their professional activity is developed in an interprofessional way. That is, when professionals learn from each other in their daily work.

Subject "Gerontological Ergonomics".

Evaluation criteria:

- The student will be able to make innovative contributions in class, seminars and tutorials.
- The student identifies, analyzes and discusses the contributions of ergonomics in the gerontological and geriatric field
- The student identifies, analyzes and discusses the utilities of the anthropometric assessments in the major.
- The student identifies, analyzes and makes a proposal about the resolution of external and domiciliary architectural barriers.
- The student designs a home space without architectural barriers.

Evaluation methods:

The evaluation objectives have been explained in the previous module.

Subject "Law relative to the third age".

Evaluation criteria:

- The student will be able to make innovative contributions in class, seminars and tutorials.
- The student identifies, analyzes and discusses the contributions of the right in the gerontological and geriatric field.
- The student identifies, analyzes and discusses the possibilities of employment in relation to the care of the elderly.
- The student identifies, analyzes and discusses the contributions of labor law in relation to job opportunities in the care of the elderly.

Evaluation methods:

- Attendance and participation in classes, seminars, guided study and tutorials (20%).
- Resolution of cases. This activity will be developed in multidisciplinary teams (80%).
- 1. Attendance and participation in classes, seminars, guided study and tutorials.

Attendance: The reason for the evaluation of the attendance is to encourage the same since the learning is associated to the presence of the student in the different activities programmed by the teacher.

Participation: Mere assistance is not considered participation. Participating means contributing to the development of the different programmed activities in an intelligent and useful way for both the classmates and the teacher. The "erroneous" contributions will not be negatively assessed since they also help to clarify the difficult concepts.

This activity will accredit the achievement of learning outcomes 1, 2 and 3 and will be evaluated according to the following criteria and levels of demand:

The qualification of the attendance will be from 0 to 5 and will be 5% of the final grade of the subject. The qualification of the participation will be from 0 to 15 and will represent 15% of the final grade of the subject.

The overall grade of this attendance and participation will be from 0 to 20 and will represent 20% of the student's grade in the course. If the student does not attend any class of the modules, he/she will not be eligible for the maximum score neither of the modules nor of the course. In this section it will not be possible to increase the grade.

1. Resolution of cases. This activity will be developed in interdisciplinary teams. (80%)

The resolution of cases is an active methodology proposed for the acquisition of professional skills. This learning method is an approach to a more autonomous learning style, more efficient and that allows the student to acquire those professional skills that will be more useful in their professional practice.

Interdisciplinary work is of great importance in the field of gerontology, since the elderly can benefit, both in health status and affects various pathologies, from the care of multiple professionals. The benefit that can be obtained from these teams is greater if their professional activity is developed in an interprofessional way. That is, when professionals learn from each other in their daily work.

4. Methodology, learning tasks, syllabus and resources

4.1. Methodological overview

The learning process that has been designed for this subject is based on the following:

The subject has a mixed orientation, both theoretical and applied, therefore the activities that are planned are focused on the acquisition of a series of knowledge and skills related to the aspects of the management of centers oriented to the elderly, knowledge and related skills with the ergonomic aspects in the elderly and with the civil, criminal and labor aspects in the gerontological field.

4.2. Learning tasks

The program offered to the student to help him achieve the expected results includes the following activities:

- 1. Theoretical classes: Expository and explanatory content sessions. Always accompanied by debate sessions.
- 2. <u>Seminars</u>: problem-based learning and case resolution. With defense in them of the results obtained.
- 3. Guided studies: students work with the ability to obtain relevant information and respond to it.
- 4. <u>Individual work</u>: It includes the study of contents related to the theoretical classes, preparation of seminars, data analysis, search of information and complementary readings and writing of works.
- 5. Group work: It includes the preparation of seminars, data analysis, information search and complementary readings.
- 6. <u>Tutoring / evaluation</u>: Direct attention to the student. Identification of learning problems. Orientation in the subject. Both the skills learned and the attitudes that have been detected with deficiencies in the rest of the training activities are evaluated. In the case of continuing to detect deficiencies, complementary activities are provided.
