 - o Cultural studies and history from below.
 - o British marxism: Thompson, Hobsbawm, Hill, and Williams.
 - o Microhistory: at ground level.
 - o Other contributions.
- Topic 3. The theorists of Cultural History. From Buckhardt to Chartier.
 - o The origins: Burckhardt, Huizinga.
 - o In Paris: Bloch, Le Goff, Duby, De Certeau.
 - o Perspectives from Philosophy and Sociology: Foucault and Bourdieu.
 - o The civilization by Norbert Elias.
 - o Peter Burke: from popular culture to cultural hybridism.
 - o Cultures, stories, popular readings: Mandrou, Darnton.
 - o Carlo Ginzburg: biography, readings and transgression.
 - o Roger Chartier: Cultural History of the social sphere.
 - o Natalie Zemon Davis and women's history.
 - o The New Cultural History and Postmodernism.

 - o The history of books and Reading.
 - o Sense and Sensibility.
 - o Political cultures, public spaces, public opinion.
