4.1.Methodological overview

The methodology followed in this course is oriented towards the achievement of the learning objectives. It is based on expository didactic techniques and participatory techniques that favor the the acquisition of theory concepts and the development of the learning process, allowing the teacher to realize the problems and concerns that may arise in the various topics. A wide range of teaching and learning tasks are implemented, such as theory sessions, practice sessions and tutorials.

4.2.Learning tasks

The programme offered to the students to help them achieve the learning results includes the following

activities:

- **Lectures** (30 hours). 30 sessions of 1 hour each. Here, the fundamental concepts of the topics of the syllabus will be explained by the teacher.
- **Practice sessions** (30 hours). 30 sessions of 1 hour each. They will involve 2 kinds of activities:
 - o Activities to learn theoretical concepts involving the active participation of the students, since they will apply already acquired knowledge to the understanding of new concepts.
 - o Resolution of practical exercises.
- **Tutorials**. They allow a more direct and personal support to students in order to answer questions about the contents of the subject and guide them in their studies and in the resolution of exercises. These tutorials may be individual or in a group.
- **Autonomous work and study** (72 hours).
- **Final exam** (2 hours).
