### 4.1.Methodological overview

The methodology followed in this course is oriented towards the achievement of the learning objectives. A wide range of teaching and learning tasks are implemented, such as theory sessions and practice sessions.

### 4.2.Learning tasks

This course is organized as follows:

- **Lectures** (45 hours). The purpose of this course is conveying the concepts of the subject in a clear, systematic, concise and entertaining way. It also aims to arouse interest on the subject and to motivate students in their individual study. The teacher will explain the legal concepts, institutions and principles of the program of the subject. That explanation is not exclusively theoretical or conceptual, but will also emphasize on the practical use of transmitted knowledge. Thus, it seeks to promote critical thinking and attitude to law. It is proposed that the lecture is rather a conversational space in which not only the teacher talks, but also questions and doubts are resolved and occasionally discussed and debated.
- **Practice sessions** (15 hours). The teacher will provide students with practical activities through the moodle platform.
- **Tutorials** (23 hours).
- **Visits and assistance to different activities** (10 hours). Seminars, conferences and visits to different companies.

- **Autonomous work and study** (50 hours). It includes the individual preparation for lectures, practice sessions and exam.
- **Exams** (7 hours).
