4.1. Methodological overview

In the case of students who necessarily have to enrolled in the Internship course, the Master's dissertation must be an original study related with some of the Master's contents. As a general rule, the dissertation will relate as well with the specializations studied during the Master's and/or the practical exercises. The dissertation is an autonomous work which will contain sufficient original elements and the necessary cited sources (see Article 3.5 of the Agreement of 11 September

There are two types of dissertations (according the Article 4 of the Agreement of September 11):

- a) Specific academic work;
- b) Specific laboratory work;
- c) Specific work as a result of internships in companies or institutions;
- d) Equivalent work elaborated as the result of stays in other university, Spanish or foreign, because of mobility programs.

The dissertation will take the form of a written report or project accompanied, when appropriate, by the necessary and complementary material in accordance with the procedures established by the Center.

In the particular case of MUPRL, dissertations can take the following alternatives:

Applied intervention: describe and analyze a problem in the Occupational Health and Safety in a company (public or private), in a public institution, or in an External Prevention Service. The student elaborates a proposal or United

Nations Project which contributes to the development of the involved company, service or institution, and it is related to the addressed problem.

 Technical or legal research: describe, analyze and/or explain empirical or theoretical problems associated with the Master's contents or internships.

All dissertations should include the following sections:

- Goals
- Methodology
- Innovative reviewed contribution
- - References used

In the case of those students who don't need to enroll in the internship course, they will do the research format. The topic of research will be agreed with the tutor.

4.2.Learning tasks

The dissertation must be carried out under the supervision of a tutor appointed by the Master's Commission on Quality Assurance. If the tutor does not have a PhD title, they should share the supervision with someone who holds a PhD. As a general criterion in the appointment of tutors it will be taken into account the students' field of specialization as well as the tutor's. The taks to be performed for the dissertation will be indicated by the tutors.
