4.1. Methodological overview

The teaching staff of the Degree in Pshycology and the Master's degree in PGS will offer, during the month of July, their research lines and the number of Master's Dissertations (TFM) that can handle.

In September, after the course enrollment, students will choose the TFM and supervisor according to their academic grades from the first year of the Master's. Also, the students collaborating with some professor included in the TFM supervisor list by:

- [1] Collaboration scholarship by the Dpto. de Psicología y Sociología during the first year of the Master;
- [2] Scholarship or research contract active during the first course of the Master of at least 6 months full time duration or its equivalence in part-time;
- [3] Scholarship or research contract granted for the second year of the Master, previous to the TFM election, of at least 6 months full time duration or its equivalence in part-time;

will be able to request that their TFM supervisor will be the same which with they are collaborating with. To do so, the supervisor must send to the Masters' CGC the documents justifying the collaboration previously to the assignment.

Students, independently, will have enough time to carry out all activities required for the elaboration of the TFM, using materials and resources recommended by their supervisors.

TFM submission

- 1. During the period established to deposit the TFM, students will send to the Master's coordinator the TFM together with the Authorization to present the TFM signed by the director, both in pdf.
- 2. Students will deposit in secretariat the Authorization to present the TFM signed by the director in pdf together with the Zaguan receipt after upload the TFM to the Unizar repository.
- 3. Through the Moodle platform it will be announced the TFM allocation to the called courts. Once students know this information they should send the TFM in pdf by email to all court members.

Note: In the case of a health emergency that require an enclosure or hybrid teaching modality (online and offline), the point 2 could be replaced by emailing these documents to the coordinator.

4.2. Learning tasks

The course includes the following learning tasks:

- In September, after the enrollment period, there will be an explanatory class. The Master's coordinator will present the TFM guidelines and will clarify any questions that students may have.
- TFM-related tutorials should be scheduled by students and supervisors, and can be individual, in group or virtual. In tutorials, students will solve specific questions about the activities being developed regarding the TFM, and the supervisors will review and evaluate the progress made by the students.

4.3. Syllabus

There is not specific syllabus for this course. The students enrolled in this course will have access to the TFM guide in the Master's webpage.

4.4. Course planning and calendar

The submission and defence of the TFM will be announced with in advance.
