#### 1. General information

The course aims to provide a deeper understanding of the social protection of women in all areas. It provides a general and special overview of all social protection within the framework of the study of gender relations.

These approaches and objectives are aligned with the following Sustainable Development Goals (SDGs) of the United Nations Agenda 2030 (<a href="https://www.un.org/sustainabledevelopment/es/">https://www.un.org/sustainabledevelopment/es/</a>), so that the acquisition of the learning outcomes of the subject provides training and knowledge, skills and competencies to contribute to some extent to the achievement of Goals 1,5 and 8.

### 2. Learning results

- 1.- Handle and reflect on social security and women's issues.
- 2.- Differentiate between direct and indirect discrimination in the field of social protection regulations.
- 3.-Know all the conciliation measures.
- 4.- Assess current benefits and subsidies for women and their families.
- 5.- Detect the areas in the relationship between gender and Social Services.
- 6.- Promote equal conditions in the field of research and care provision.
- 7.- Interpret the prevention measures that affect the work.

### 3. Syllabus

BLOCK 1: Conciliation and co-responsibility measures and protection of women's work

BLOCK 2: Types of harassment in the workplace

BLOCK 3: Development of social services: Delimitation and scopes in the relationship between gender and Social Services.

BLOCK 4: Public-legal mechanisms for the protection of equality.

### 4. Academic activities

The learning process designed for this subject is based on the following:

Labour and Social Security Law: 3 ECTS

Administrative Law: 2 ECTS

Social Work and Social Services: 1 ECTS

The activities are divided into:

Master class 22.5 hours of lecture sessions

37.5 hours of practical content, analysis of texts, essays, debates, etc., as well as visits to institutions

Student work 12 hours

#### 5. Assessment system

#### 1.-Mixed system

- a) Attendance to face-to-face sessions. Those who have attended and actively participated in all sessions will receive a grade of 10 out of 10. If the student has missed any session or has not participated in an outstanding way, the grade will be 9.5 out of 10. If there have been 2 or more absences, up to a maximum of 50% of the sessions, the student must prepare works on the material provided by the teacher whose sessions could not be attended.
- b) Production of a work At the end of the course, an individual or small group work (maximum 3 persons) will be presented. The topic can be chosen between an equality plan or a commentary on prostitution. The minimum length shall be 5 pages. The summary of the facts of pronouncement shall only be 1 page long. The length will be proportional to the number of authors. It will be graded out of 10.
- c) The final grade will be the average of a and b
- 2.- Simple system based exclusively on the final global test.

The teacher in charge will indicate the summary, commentary, or reading that will replace the face-to-face sessions and a final test of all the contents taught will be given on the dates indicated in the master's calendar.
