1. General information

The subject Social Work in the field of Justice aims to provide students with knowledge of the different forms of professional practice and intervention of social workers in the judicial and penitentiary contexts that make up the justice system in our country.

The interventions of Social Work in Judicial Institutions and criminal areas that have to do with the application of the specific procedures of the expert social reports are analyzed.

Simulated approximations of intervention plans linked to professional practice are carried out in the different contexts and areas of Justice (adults, minor victims, offenders, families.

To this end, the various problems and the institutional and social resources available at the state, regional and local levels are identified.

2. Learning results

In relation to the nature of social intervention cases:

4. Academic activities

The realization of each of the theoretical presentations (T1), based on the appropriate bibliographic contributions that are structured in the Thematic Units, will be carried out in constant teacher-student interaction through a teaching-learning process. This direct involvement of the students involves active preparation of the class using the appropriate materials and instructions that will be in the ADD. Which will involve a search for complementary information, study and presentation of cases, etc. that facilitates the application of knowledge and the development of skills. There will be an exam-type evaluation at two times during the semester.

In the practical part, T2, study of the different cases subject to social intervention, both in relation to the different institutional and judicial spheres and in the various contexts of intervention - individual, family, etc. - What a case study entails detailed and detailed in attention to the requirements for professional praxis whether from the reform institutions -juvenile justice-; from the penitentiary context or from coordination with social entities in the sector. To do this, students will prepare a personal internship dossier and a group research project, which systematically or transversally analyzes in depth some aspect of the thematic lines of the proposed syllabus.

5. Assessment system

A continuous evaluation system is carried out as an active teaching-learning process in class, which will involve direct involvement of the students in the construction of the proposed syllabus; There will be prior preparation work for the class, which will upload the contents that will be worked on to the ADD. Thus. The progress of each of the students will be evaluated through two content tests and active participation in class dynamics.

The evaluation of T1 will have a value of 50% of the total weight of the grade.

T2 -practices- have a specific weight of 50% in the final grade. Within T2, a group research work will be carried out that, in a systematic or transversal way, will analyze with methodological rigor some of the thematic lines presented in the syllabus. This work will be directed by the teacher.

There is a single evaluation option, you must always contact the teacher during the first two weeks of the course. The evaluation criteria are similar to those for continuous evaluation. (T2 Dossier, research work and exam).

To pass the subject it is necessary to pass both component parts -T1 and T2- in order to average the final grade.
