#### 1. General information

The main objective of the course is to provide the student with conceptual and analytical instruments to establish the correlation between political forms and ideological forms, from Augustus to Theodosius I.

This objective is aligned with the Sustainable Development Goals (SDG) 4, 5, 10, 16 and 17 of the United Nations 2030 Agenda.

Within the optional Ancient World Module, the subject contributes to improving the student's ability to understand the processes of crisis and transformation, taking into account the events in their sequence and the lines of continuity and social, political and ideological rupture.

# 2. Learning results

- -Includes the specialized contents of the subject, in particular, the political, social and ideological processes of the Roman Empire as a power structure (CE5).
- -Is able to establish correlations between political and ideological forms (CE5).

#### 3. Syllabus

- I. Program of theoretical activities: thematic blocks
- 1. Political power and the sacral dimension of imperial power: grammar and syntax of imperial ideology (1st and 2nd centuries)
- 2. The emperor of the ss. III and IV in words and images.
- II. Program of practical activities:

Texts from the RGDA, Tacitus, Pliny the Less, Latin Panegyrics, Lactantius, Eusebius of Caesarea, Julianus, and Ammianus Marcellinus, among others, will be proposed, discussed, and resolved, with the active participation of the student body.

### 4. Academic activities

- 1. Interactive knowledge exhibition.
- 2. Resolution of problems and practical cases that emanate from the theory.
- 3. Presentation of supervised works.

4. Individual and group work to study the contents.

With class attendance, the preparation of the theoretical class program, participation in practical activities, critical performance of the recommended readings and the preparation of an essay, students will be provided with information search methods, references and reference systems. on the plurality of contents that make up the subject. To this end, the instruments of analysis of historiography, epigraphy, archeology and the analysis of material culture will be used, but also of legislation, numismatics, iconography, social anthropology and historical sociology and of the religions.
