Jobs Master Thesis (TFM) constitute an autonomous personal work of the student and will consist of performing a memory or a project and reveal the knowledge, skills, aptitudes and attitudes acquired by the student throughout the degree and contain sufficient personal creation and properly cite all sources usadas.

In any case be realized in a memory or project in written form accompanied, where appropriate, the material is deemed appropriate in accordance with the procedures established by the Centre.

5.2.Learning activities

The realization, presentation and defense of Master's Thesis (TFM), completes the curriculum of the Master, demonstrating the student's ability to integrate, apply and develop different conceptual and methodological aspects learned during the Master, to perform and publicly presenting a Draft Basic Research, cynical, translational or applied in the field of medicine.

Works Final Master (TFM) constitute an autonomous personal work of the student and will consist of performing a memory or a project and reveal the knowledge, skills, aptitudes and attitudes acquired by students throughout the certification and contain sufficient evidence of personal creation and properly cite all sources used. The theme of T.F.M. It will be established in agreement with the director or directors.

5.3.Program

The presentation of the proposed Master's Thesis (TFM) will be held at the Secretariat of the Centre: from enrollment until the last week of May, in standard format (Anexo I), which shall contain the following: 1. Title planned 2. Summary of the work to where the context, problems and objectives of the proposal, well 3. Visto and acceptance of the director shall be indicated.

Within a period of time not to extend beyond the end of the month following its presentation, proposals for the work will be informed by the Academic Committee of the Master, which may approve, reject, or request the student or the principal information Further thereon.

Two calls for TFM defense are set, according to the schedule established by the relevant courts: June 20 to July 15 and from 8 to 20 September, which registered students will communicate and be exhibited in public newscasts adapted for this finally, in the Secretariat of the Faculty of Medicine, with a minimum of 15 calendar days and in that place, date and time and composition of the courts and list of invited students be specified.

5.4.Planning and scheduling

Schedule sessions and presentation of works

Address .

It is regulated by Article 5 of the Agreement of 11 September 2014, the Governing Council of the University for Regulation of work approved Master's Thesis at the University of Zaragoza:

1. Master's Thesis work will have a director, at least, that will safeguard and supervise the work of the student.
2. The principal or any of the co-directors must belong to the staff of faculty of the University of Zaragoza and one of the areas of knowledge related to the corresponding degree or should be part of the staff of research staff at the University of Zaragoza or Joint Centers. The Quality Assurance Commission of the degree Exceptions may any of these conditions to recognized professional issuing a favorable reasoned report.

When not meet the above conditions or in exceptions will be necessary to appoint a teacher or member of the research staff at the University of Zaragoza that meets and assume the work of the rapporteur, endorsing the adequacy and quality of the work presented.

4. To lead or co-lead work to master the condition doctor will be necessary. Exceptionally, the Quality Assurance Commission a Master degree may authorize the management or co-management professors not doctors with a reasoned report.

The Quality Assurance Commission titration procedure may provide the address assignment to Master jobs, taking into account the specificities of this.

The theme of the work is determined by agreement between the student and the director. Ultimately, the Commission on Quality Assurance titling ensure the allocation of subject and director for all students enrolled. Validation by the director and safeguarding the process of carrying out the work.

The direction of the work will be reflected in the record of the management plan Teaching the teacher and will be recognized in the terms established in the regulatory provisions of this University.

Proposal

Presentation of the proposed Master's Thesis, in standard format * (Annex I), which shall contain the following: Title anticipated. Summary of the work to where the context, problems and objectives of the proposal indicated. Approval and acceptance by the Director.

Place and dates of submission: Secretariat of the Centre: From the registration until the last week of May.

Within a period of time not to extend beyond the end of the month following its presentation, proposals for the work will be

informed by the Academic Committee of the Master, which may approve, reject, or request the student or the principal information Further thereon.

Announcements

Two calls for Works defense are set, according to the schedule established by the relevant courts: June 20 to July 15 and from 10 to 20 September, which registered students will communicate and be exhibited in public newscasts adapted for this finally, in the Secretary of the Faculty of Medicine, with a minimum of 15 calendar days and in that place, date and time and composition of the courts and list of students summoned shall specify.

In response to any allegations or any comments prior to the defense court, the author or director /- s or, where appropriate, rapporteur, may decide to keep it in its original state, modifications, or withdraw it at any time before beginning the defense.

In the event that the withdrawal of the Master's Thesis is decided, you must restart the entire process of deposit and defense.

Warehouse work

The student must deposit their TFM in the way they have arranged the center, with the approval of the director or co-directors, over the twelve months following enrollment. After the previous deadline had been made without the deposit, the student must register again.

TFM are deposited with the Secretariat of the Centre, once they have passed the 48 credits required prior to its defense.

Format deposit : Entries should be submitted in text files and still image formats and according to official guidelines of the University of Zaragoza, unless the content of the subject requires a dynamic format.

The Quality Assurance Commission of the degree have what must be the size of memory or project and its annexes. Jobs Master Thesis will be part of the bibliographical corpus of the University of Zaragoza as a result of the academic production of its students.

For this purpose, a procedure for electronic deposit will be enabled in the document repository of the University of Zaragoza (ZAGUAN). This procedure is mandatory prior and public defense of the work.

In any case, the file of work to master ensure copyright as established in the current legislation

While the procedure for processing work to master is not active on the Electronic Office of the University of Zaragoza, schools may ask students the number of copies they deem appropriate * without imposing requirements on the binding :
* *When making the deposit the student must provide: A brief report of the Director of Labour authorizing submission and three copies of the Labour memory*

Court

The court or courts assessors shall be appointed as provided for that purpose by the Commission on Quality Assurance of the degree.

Each evaluator tribunal shall consist of three doctors members to be proposed by the Commission Quality Assurance Master and at least two of them are professors at the University of Zaragoza. They can also be part of the courts, with the requirements that apply in your case, the researcher at the University of Zaragoza or Joint Centers staff.

Presentation and Defense

The defense will take place once the student has passed all other subjects or subjects leading to the official qualification, within the course which had been registered or the next.

The student must proceed to the public defense TFMr before the appropriate court assessor within the periods that each center established for the purpose, at least two per course.

The student may be submitted at most twice. After that time had passed without defense, the student must enroll again.

The defense of TFM is held in public session, on specified dates, in school period and before the full court.

The exhibition will last a maximum of fifteen minutes, which can continue a discussion with members of the Tribunal on his presentation, content and methodology.

Qualification

The rating of the work will be done with the same scale as the other subjects of formal qualifications. In the event that the note is less than five, the court shall specify the appreciated defects, indicating the modifications that will be necessary to carry out at work or a new defense thereof.
