The purpose of this paper is to examine the current linguistic situation of Nigerian Pidgin English based on the parameters of pidgin languages established by sociolinguists. This paper will aspire to see whether it follows the general features of pidgin languages as its name implies. The reasons for this study are the necessity of seeing whether its name accurately fits the description of the language. Moreover, the determination of its relation, in terms of proximity, to Standard English is another rationale for the study. My hypothesis is that Nigerian Pidgin English has passed the linguistic stage of a pidgin being that it barely follows the main features of pidgin languages. This is probably because it presents a more complex stable set of norms despite not being standardized.

English-based pidgins

In comparison to standardized varieties of the English language, there are others that are still in the struggle for institutional recognition due to several reasons. Many of these disputed varieties are the ones developed from the contact of the English language with other languages during its global spreading from the 17th century onwards. These present-day English-based languages, which are termed pidgins and creoles, show important linguistic features from places in Africa and Asia in which the British colonial power once settled. Wells (1982: 562) defined a pidgin as a "makeshift form of communication developed between groups of speakers of different languages." Also, Todd (1990: 1) stated that "a pidgin is a marginal language which arises to fulfil certain restricted communication needs among people who have no common language". With the passing of time, the definition appears to be the same, as Bell (2014: 79) has stated that "a pidgin is a language that is created when groups who lack a common language are in ongoing contact. It has a limited vocabulary, simplified structures and no native speakers who

learn it as a first language." As these languages are a mixture of several languages in contact, degrees regarding how much the final product is influenced by one or the other account for the terms of 'superstrate' and 'substrate'. Bell (2014: 79) explains that the main language in the mix is called the superstrate. This language, which is usually the main contributor of most of the vocabulary, is also called the lexifier. In contrast, the substrate languages are the ancestral languages of the peoples involved in this linguistic mix. These substrate languages make more contributions to the grammar of the pidgin in question. The reason for this relation of importance between the superstrate and substrate is that, as communication was to be made possible especially among several Europeans and several other Africans, Holm (2000: 5) has seen it as a sort of power dynamics that explains why African items could not exceed the number of English words and as a result impede communication: "Usually those with less power (speakers of substrate languages) are more accommodating and use words from the language of those with more power [...] although the meaning, form and use of these words may be influenced by the substrate languages."

Due to the existence of several pidgins globally and the huge differences amongst them, two main categories have been proposed based on historical, linguistic and geographical factors as Holm (2000) points out. These two categories are English-based Atlantic pidgins/creoles and English-based Pacific pidgins/creoles. He states that the Atlantic group, which was established in the seventeenth and eighteenth centuries during slave trade, consists mostly of plantation creoles of the regions of West Africa and the Caribbean area. On the other end is the Pacific group, which was largely established in the nineteenth century. Holm (2000: 92) further explains: "[t]he Pacific group consists of pidgins that are structurally quite different from the Atlantic creoles because of the different typology of substrate languages." On the Atlantic end, the most outstanding ones

include the Jamaican patois, the Nigerian Pidgin English (henceforth NPE), while on the Pacific is Papua New Guinea's Tok Pisin. NPE itself is found in a subgroup of English-based Atlantic pidgins and creoles which is West African Pidgins. This category includes the pidgins and creoles spoken in current West African countries like Nigeria, Ghana, Sierra Leone and Southern Cameroon. Out of these, Nigeria is said to "be the most strongly Anglicized" (Schneider 2007: 205). As languages are dynamic, pidgins have been studied based on the continual complexity they tend to display with the passing of time. For this reason, a classification based on complexity has been established for study and research purposes (Mesthrie 2000: 280-281):

- A **jargon** (pre-pidgin)- has relatively unstable strucutre, is composed of limited vocabulary and is frequently augmented by gestures.
- A stable pidgin (usually just labelled 'pidgin') is one which has a recognisable structure and fairly developed vocabulary, but which is in practice limited to a few domains.
- An expanded pidgin is one which has developed a level of sophistication of structure and vocabulary and is being used in many domains, including interpersonal and domestic settings.
- Creoles are languages which developed out of pidgins.

Regarding creoles, Bell (2014: 79) claims that, like pidgins, they are "created when groups who lack a common language are in extensive contact. It has a full vocabulary and complex grammar and has native speakers."

Features of English-based pidgins

Holm (2000: 290-291) grouped findings and features under lexicosemantics, phonology and syntax parameters. Meanwhile Mesthrie (2000: 290-291) gathered linguistic peculiarities under the aspects of pidgin vocabulary and grammatical structure. Other authors, such as Bell (2014: 79-80) mention previous aspects, even though without the specification of categories, and contribute more details related to syntax. Todd (1990: 14) found out that it could be clearly seen that English-based pidgins have undergone a reduction of the grammatical devices employed. Wells (1982: 562) and Holm (2000: 5) both agree that these languages (pidgins) are mainly characterised by reductions—either in morphology or phonology, as Bell (2014: 79) states. In other words, necessary grammatical resources such as inflections found in the superstrate language tend to be dropped. Mesthrie (2000: 291-292) explains that verbal markers and other necessary traits such as suffixes found in Standard English (henceforth SE) tend to be dropped. And as these inflection markers are dropped, this author observes that tense "has to be inferred from context [...] or is expressed by temporal adverbs..." On a lexical note, Holm (2000: 5) and Bell (2014: 79) state that they display reduced language and, for this reason, the words are more polysemous than in the standardised varieties of the superstrate language, while Mesthrie (2000: 280) observes that another main characteristic of these languages is that "they draw vocabulary items derived from these languages" in the mix although at different degrees. Regarding phonology, Bell (2014: 80) states their phonological system tends to be simpler. This is usually seen in the spelling of the words in these languages. And in relation to syntax, Trudghill (2002) and Bell (2014) agree that there is little subordination.

Nigerian Pidgin English (NPE)

Nigerian Pidgin English (NPE), which according to Schneider (2007: 208) stands as "the candidate for national language, at least on the affective level", is the counterpart of the standardized form of English used in Nigeria. Like most of other English-based pidgins, its origins lie on slave trade. Due to its nature, NPE holds positive and negative views among the Nigerian population. Some of the negative views (for instance, "NPE is adulterated English") have been portrayed by Akande and Salami (2010: 82). On the other hand, Egbokhare (2003) has called for the revaluation of NPE as the National Official Language. Reasons for this include the idea that it is neither totally British (imported) nor an originally indigenous (African) language. These reasons make it 'neutral' at a first glance for the over 250 extremely different peoples and over 400 languages amalgamated in the multilingual country. The roles of NPE have been shown by several studies that include those of Schneider (2007), who claims that the uses of NPE complement the spheres in which English (the official language) dominates. In terms of users, Akande and Salami (2010) found out that a high number of Nigerian graduates, professors and professionals employ this language in relaxed settings such as at home, amongst friends, and at social gatherings. Regarding its linguistic aspects, less has been written. As seen in Huber (1999 cited by Schneider 2007: 203) has observed some important and outstanding features of this language. These features, however, do not exclude the generic features of pidgin Englishes mentioned above. They are as follows:

- a) na as an equating copula, in cleft sentences and in focus constructions.
- b) de(y) as a locative copula.
- c) de/di as a progressive marker.
- d) make as a causative or imperative marker.
- e) we(y) as a relativizer.

In relation to the first three features highlighted above, Holm (2000) offers explanations. He talks about them in three sections he identifies as *equative be*; *locative be*, and *highlighter be*. Huber's *na* is explained by Holm (2000: 199) as the *equative be*, as "a true copula in the Latin sense of the word joining two others i.e. a subject and a complement as in *Mary* is *my sister*." Furthermore, he observes that in English-based Atlantic creoles, the same item *na* serves as what he terms 'highlighter', "[a] morpheme that emphasizes the word it occurs next to like English '*it's*'" (Holm 2000: 201). He also hints that the origin of this item could be the Yoruba¹ language. Regarding the locative copula *de*(*y*), Holm (2000: 199) suggests that it comes from the English adverb *there*. This word in NPE would function as the English *be* but when referring to place in a sentence.

To carry out the examination of NPE, a total number of 15 written articles with approximately 3900 words in NPE have been compiled from the website of the *BBC News Pidgin*. Most of these articles, which have been extracted from the website's homepage, were mainly published very recently in September 2018. This digital news platform was launched in 2017 with the aim of providing local and international news and current affairs to the region of West Africa in this language because, according to Bilkisu Labaran, in an article² published by the BBC, the editorial lead of the new BBC service says "it's an informal lingua franca. It is a language that really unites people and cuts across all sorts of barriers - ethnic, regional and socio-economic." The reasons for the use of this source of data are as follows. Pidginized forms of European languages are hardly institutionalized and for this reason they usually remain on an oral level. Nonetheless, the *BBC News Pidgin* offers authentic written pidgin English. Overall, the articles are quite understandable and easy to follow for those familiar with the language. Moreover, they

are based on real life events since being a newspaper they contain everyday topics such as science, politics, technology, fashion, health, sports, crime, religion and international news. Also, the website is public and therefore virtually accessible to everybody. Considering the BBC is known worldwide and enjoys global prestige, the articles published under its signature are rather reliable.

Aspects of language that include morphology, lexis, spelling and syntax will be primarily dealt with in this paper through the analyses of these features in these articles on the basis of the analytical features described above. By this, I will see whether the observations made by experts are found in NPE. Regarding the grammatical features, attention will be firstly given to the simplification observed in the prepositional system of NPE. Secondly, lexical verbs and especially the copular verb be will be examined. The generalised feature of linguistic reduction observed has accounted for the focus on prepositions and verbs in this paper. So, for the sake of an easier reading, the extracted instances will be given in full sentences that will be also translated literally into Standard English. Also, they will be tagged [T1]-[T15] for referential purposes Regarding vocabulary, emphasis will be placed on the lexical units of substrate languages and on how there may be different spellings of words derived from the superstrate language and that in effect could impede their recognition. Therefore, as the peculiarities of these spelling features will be highlighted, some pronunciation aspects will be inevitably mentioned when analysing this point. In the case of syntax, attention has been given to sentence order and its degree of complexity. In the analysis, this paper will also look out for recurrent traits or other characteristics of NPE that may not have been mentioned by experts.

Analysis of NPE features in BBC News Pidgin news texts

A. Grammatical features

The simplification and minimisation of grammar that can be observed in NPE is mainly found in prepositions and verbs.

1. The preposition for

The prepositions designated for place and time found in SE are reduced to *for*. Therefore, this preposition in NPE (in bold) is normally valid for all circumstances in which SE would require another preposition of place or time.

i. Di researchers report **for** di journal Open Science say di goats wey dem use for di study just waka straight go **for** di foto wit happy faces. [T1]

The researchers reported *in* the journal Open Science that the goats that were used for the study just walked straight *towards* the photo[s] with happy faces.

In this first case, for appears to substitute the SE in for place.

ii. Nigeria election join bodi Independent National Electoral Congress (INEC) don announce say di result of di Osun state govnorship election for 2018 na 'inconclusive'.[T4]

Nigeria Election alongside Independent National Electoral Congress (INEC) have announced that the result of the Osun state Governorship Election *in* 2018 is 'inconclusive'.

In this second case, for appears to substitute SE in for time.

iii. INEC returning officer Professor Adeola Afuwape announce for live TV say main opposition party Peoples Democratic Party (PDP) get 254, 698 votes while di candidate of di ruling All Progressive Congress (APC) party get 254, 345 votes. [T4]

INEC returning officer Professor Adeola Afuwape announced *on* live TV that [the] main opposition party- Peoples Democratic Party (PDP) got 254, 698 votes while the candidate of the ruling All Progressive Congress (APC) party got 254,345 votes.

In this third case, for appears to substitute SE on for place.

2. Verbal structure

In the case of verbal simplification, at a first glance the infinitive forms of verbs have been found along all the articles. However, a steady pattern of verbal conjugation has been noticed. This pattern shows that NPE has progressive and perfect verbal markers alongside a future simple marker. The word *dey* tends to act as the SE auxiliary *be* while *don* works as the SE auxiliary *have*. The word *go*, when not used as the main verb, appears to be a substitute for the SE *will* or *going to*. These NPE auxiliaries *dey*, *don* and *go* are also simplified to the point that they do not show either persons or tense. Also, as the verbal system has been simplified to eliminate verb endings, it has also been observed that the infinitive form of a verb could refer to the present simple as well as the past simple. For negative sentences, *no* is added before the main verb or the auxiliary. In the case of interrogative clauses, it is more frequent to find them formulated in an SVO order, unlike SE, in which an inversion of the subject-verb occurs. Moreover, interrogative clauses do not tend to show SE auxiliary 'do, does, did'. I have summarised this in Table 1 below.

The following examples show different ways of verbal simplifications found in the sample.

i. Example of present perfect:

Scientists don find out say goats like stay wit humans wey get happy face. [T1] Scientists have found out that goats like staying with humans who have got happy faces.

ii. Example of present perfect continuous:

If you don dey follow wetin dey trend for social media for di past few days, den you for don hia say one Nigerian don become di world highest paid robotics engineer. [T5]

If you *have been following* what has been trending on social media for the past few days, then you must have heard that one Nigerian has become the world's highest paid robotics engineer.

iii. Example of present simple or past simple:

Di result **suggest** say plenti animals fit read di mood of pipo than di way we tink before. [T2]

The results suggests/suggested that plenty animals can read the mood of people [unlike] the way we previously thought.

In this case, the verb *suggest* could be interpreted as past simple or present simple.

iv. Example of present simple negative:

I no want anybodi to go through di kain depression I suffer. [T9]

I do not want anybody to go through the kind of depression I suffered.

v. Example of present continuous:

Afta dia battle for almost twenty years or so, India LGBTQ community wey be (lesbian, gay, bisexual, transgender and queer) don finally dey rejoice. [T6]

After their battle of almost twenty years or so, [the] India LGBTQ community which is (lesbian, gay, bisexual, transgender and queer) are finally rejoicing.

vi. Example of simplification of 'be going to' to express future intentions:

US go deport 7000 Ghanaians after diplomatic agreement plus Ghana [T11]

The US is going to deport 700 Ghanaians after diplomatic agreement with Ghana.

3. The SE verb be

(problem)

In the texts under study, the SE *be* has been found, unconjugated, in fewer occasions in comparison to the word *dey*, which substitutes SE *be* in all senses.

- i. South Africa go **be** di first African kontri wey go legalise igbo or marijuana as dem **be** di third kontri for world. [T2]
 - South Africa is going to *be* the first African country to legalise Indian hemp or marijuana while they *are* the third country in the world.
 - In this case, it could be translated as the infinitive form of the verb to be in SE.
- ii. Professor Abiodun Adewuya wey be Principal Investigator Mental Health in Primary Care (MeHPhric) Lagos project say im NGO dey help make Primary Health Centres fit treat pipo wey get mental health palava. [T9]

 Professor Abiodun Adewuya who is the Principal Mental Health Investigator in Primary Care (MeHPhric) Lagos project says that his NGO is helping Primary health Centres to be able to treat people who have got this mental palaver

iii. Tennis Head coach for Oyo State Sports Council, Saliu Tirimisiu say "pipo dey forget say umpires dem be human beings and e possible say dem fit make mistake."[T12]

Tennis Head coach in Oyo State Sports council, Saliu Tirimisiu said "people forget that umpires *are* human beings and it is possible that they can make mistakes.

The last two cases are examples of the unconjugated verb due to the characteristic feature of simplification of the superstrate language found in any pidgin.

Apart from SE *be*, there are occurrences of the word *dey*, which acts as a SE copula or as SE auxiliary *be* can be seen in the following cases:

- i. Bill Cosby dey face up to 10 years for prison. [T13]Bill Cosby is facing up to 10 years in prison.
- ii. Versace fans dey breathe fire and brimstone afta Michael Kors buy am over[T7]

Versace fans *are breathing* fire and brimstone after Michael Kors [has] bought it (Versace) over.

In both cases, *dey*, acts as the SE auxiliary be for progressive tenses.

iii. Although di judgment mark one win, di fight still dey on inside and outside di courtroom as di LGBTQ community still dey find way for pipo to accept dem in terms of marriage laws, adoption laws, and more [T6]

Although the judgement marked one win, the fight *is* still on inside and outside the courtroom as the LGBTQ community is still looking for ways to accept them in terms of marriage laws, adoptions laws and more.

However, in this last case, it could be interpreted as a locative copula. (See more examples in Appendix V)

B. Lexical features

1. Polysemy

Regarding lexical features, it could be observed that the minimisation of vocabulary units will account for the existence of more possible meanings given to a word in comparison to that same word in SE. In the sample, a recurrent word that presents a meaning totally different from the ones it expresses in SE is *say*: it appears to work as the SE conjunction *that* in NPE. This occurs when it is not acting as the main verb. It normally comes after a reporting verb. Also, it could possibly stand as the SE relative pronoun *that*. In such case, it should introduce a subordinate clause as in SE.

i. Di result suggest say plenti animals fit read di mood of pipo than di way we tink before. [T1]

The results suggested *that* plenty animals *can* read the mood of people [unlike] the way we previously thought.

In this extract, the rather frequent word 'say' is given and it could be considered as the English conjunction *that*. Also, *fit*, which is either an adjective or a verb in SE tends to substitute the verb *can* in SE.

ii. Animals wey human dey train to chop like goats, fit also know how pesin dey feel. [T1]

Animals which humans train *to be eaten*³ like goats, <u>can</u> also know how [a] person is feeling.

In this extract, the lexical shift occurs in the verb *chop* and *fit*. This first word which in SE means to cut something into smaller pieces acquires the meaning of *eat* in NPE. Further, as explained above, the SE adjective *fit* changes word class and meaning to the verb *can/could/be able to*.

iii. Wen BBC Pidgin go Nkpolu Rumuigbo, we see say all di shop for di area don close sake of di flood water wey don enta come stand for di shop. [T3] When BBC Pidgin went to Nkpolu Rumuigbo, we saw that all the shops in the area had closed because of the flood water that has entered the shops.

2. Non-superstrate words

The analysis has also unveiled a number of words that appear to come from substrate languages. Given the vast linguistic map of over 400 African languages of present-day Nigeria, it is difficult to account for the possible origins of these words. One of these words is na, which Holm (2000) observes could be similar to the word 'no' from the Yoruba language, and serves the same function of emphasizing what comes after it. It could be translated as it is or the highlighter be found in SE cleft sentences. Holm (2000: 201). Secondly, the word pikin, which means 'child', appears to derive from Portuguese pequenino, meaning 'little child.' The analysis has shown a number of different instances where words of different origins have been found as table 2 shows below. The table shows substrate words, their translation and possible origins is given. The (-) represents an unknown word in terms of origin or meaning.

C. Spelling

Simplification in spelling has also been observed in these articles. The simplification of these words could be resultant of the simplification of phonology as observed by Bell (2014). The analysis of the sample has shown that NPE certainly has a simplified phonological system based on lacks and omissions. Firstly, it appears that it lacks the SE schwa, which is normally found in unstressed syllables and at the end of words in SE, as in *afta* (after), *betament* (betterment), *enta* (enter), *pipo* (people), *mata* (people), *neva* (never), *oda* (other), *palava* (palaver), *qweshon* (question), and *weda* (whether). Moreover, SE consonant cluster "th", which is pronounced in three different ways in SE (/t/, /e/, /d/), has been reduced to only /t/ and /d. Instances of this case include *anoda* (another), *di* (the), *evritin* (everything), *gada* (gather), *oda* (other), *tink* (think), *tins* (things) and *weda* (whether). Also, there appears to be an unusual omission of consonants as occurs in *goment* (government) and *tori* (story). The analysis has shown a number of different instances where English words show different spellings based on said phonological simplification. origins have been found

as seen in table 2 below. The table shows the words, their translation and texts in which they appear.

D. Clause structure

1. Clause order

Concerning clauses, a generalised feature of all English-based pidgins is that they tend to follow an SVO order in affirmative, negative and interrogative sentences. So, unlike SE, there would be no verb subject inversion for interrogative purposes.

- i. Judges dey fair to man and woman athletes? [T12]

 Judges are fair to male and female athletes?
- ii. Dis Nigerian na di world highest paid robotics engineer? [T5]



This Nigerian is the world highest paid robotics engineer?

However, the sample shows cases where the interrogative clause follows the SE order:

iii. Wetin be dis section 377? [T6]
What is this section 377?

2. Clause complexity: the use of subordinators

Being that these languages are said to be simplified versions of their superstrate languages, it would be expected that they show simplified syntactic structures such as few subordinated clauses as Bell (2014) states. Nonetheless, as NPE, makes use of the word say for the SE conjunction that or even the relative pronoun that, it would be reasonable to see if they have the same syntactic functions as in SE.

In the following examples, *that* is a conjunction that introduces a subordinate nominal clause acting as direct object. In these examples the subordinate clauses will be underlined.

i. Trade Union Congress (TUC) bin don announce say dem go begin strike for early mor-mor on Thursday 27 September afta federal goment for Nigeria fail

to meet up wit di deadline to call back di meeting wia dem dey discuss di new minimum wage mata for workers. [T8]

Trade Union Congress (TUC) has announced *that* they will begin strike on the early morning of Thursday 27 September after the Federal Government of Nigeria failed to meet up with the deadline to call back the meeting where they are to discuss the new minimum wage matter for workers.

- ii. I begin think say na spiritual problem. [T9]I began to think that it was a spiritual problem.
- iii. On Sunday, dem dey expect say 500,000 pipo go gada for park for Dublin as di Pope do Mass to celebrate di World Meeting of Families. [T15]
 On Sunday, they were expecting that 500,000 people would gather in the park in Dublin as the Pope did the Mass to celebrate the World Meeting of Families.

In all the examples above, the word say in NPE appears to act as the conjunction that whenever it is not used as the main verb. Also, as say in NPE tends to take this function, the word tok, from talk in SE, tends to work as the initial meaning of SE say.

Also, apart from *say*, SE relative pronouns and adverbs tend to have been reduced to *wey*, *wen* and *how* in NPE. Being that NPE has relative pronouns, NPE relative pronouns may also serve the same purpose of subordination as in SE. Examples are as follows:

i. Animals wey human dey train to chop like goats, fit also know how pesin dey feel. [T1]

Animals *that* <u>humans train to be eaten</u>⁴ like goats can also know how [a] person is feeling.

In this case, *that* is a relative pronoun that introduces a subordinate relative clause. The relative pronoun functions as direct object.

ii. But wen BBC News Pidgin send email go im company, Reach Robotics, di press team say "di gist wey dey circulate for Nigeria news website no correct in some ways. [T5]

But when [the] BBC News Pidgin sent [an] email to his company, Reach Robotics, the press team said "the gist that is circulating on Nigerian news website [is] not correct in some ways".

The relative adverb *when* introduces an adverbial clause of time. The relative pronoun *that* introduces a relative clause.

iii. Nigeria journalist Latipha Adebayo, wey dey follow di sport wella tell BBC

Pidgin say "she no believe di sport dey sexist" as most of di tins like "players

welfare, prize money don dey ok." [T12]

Nigerian journalist Latipha Adebayo, who follows the sport a lot, tells BBC Pidgin that "she does not believe the sport is sexist" as most of the things like "payers welfare, prize money have been ok".

The relative pronoun *who* introduces a non-defining relative clause. The next subordinate clause is a nominal clause introduced by the conjunction *that*.

Conclusions

This study has set out to examine the current linguistic state of NPE based on articles published by BBC News Pidgin. The corpus has consisted of approximately 3900 words from 15 different articles. On the one hand, I have found out that NPE is not a just a pidgin in terms of the simplification of a language for basic communication, but a rather complex language based on the minimisation of some grammar aspects of its superstrate language. This complexity has also been observed in the variety of topics dealt with in the texts, the use of several tenses and the presence of complex sentences. On the other hand, inconsistencies regarding some of the patterns have also appeared. Based on the translation of several excerpts of the corpus, it could be argued that the absence of the passive voice in the corpus denotes the inexistence of this linguistic feature in NPE. NPE appears to be more complex than a pidgin per se, given the time it has been in existence, the high number of users who employ it as their first language and finally, the complexity of the linguistic traits shown in this paper. Therefore, a subsequent conclusion would be the adaptation of its name from Nigerian Pidgin English to Nigerian Creole English, being that the previous is less descriptive. The requirements for a pidgin to become a creole is firstly having children born into it and making it their mother tongue. And secondly, for this extended pidgin to be able to be used in every domain of life- not only for specific contexts such as trade. In the case of NPE, both requirements appear to be fulfilled. Furthermore, as NPE lacks institutional support and recognition, as Akande and Salami (2010) have pointed out, it could be argued that a resulting effect of this neglect is the presence of aspects of NPE that are neither fixed nor consensual amongst its users as there is no institutional body that governs it and it is used by millions of speakers. These aspects include variations in clause order found in interrogative clauses and the unspecified use of SE be, dey and na. A standardisation of the language would require the establishment of norms and set grammar rules that would constitute a model for uniformisation. The analysis of the texts that comprise the sample has encountered certain limitations, such as the fact that the sample is already refined material from a news media outlet. The reason for this is that as there is no institutionalised body to govern the language, so, what any individual would utter as NPE cannot be verified. Also, the idea of these articles written in "West African Pidgin" as said in the article mentioned on page 8, could be misleading, being that the term "West African Pidgin" is quite broad, as it includes English-based pidgins used in Liberia, Ghana, Nigeria and Southern Cameroon. Although they share some general features, their substrate languages do differ and that may impede communication amongst speakers of different nationalities. Also, it must be said that, their production hub is located in Nigeria and their chief editor, Bilkisu Labaran, is a Nigerian-born journalist living in Nigeria. So, chances are high that the language used in these articles may be highly influenced by NPE.
