The learning process that is designed for this subject is based on the following: Among the 40 % dedicated for classroom teaching, 60% will be dedicated to the training activity number 1 in the methodology in the classroom and it will be spend 40 % to the training activity number 2 with the methodology of solving practical cases and practices in the classroom or outside it. This is justified by the special characteristics of the subject of law and ethics as reflected in the skills acquired by the students , which require the preparation of solving practical cases based on the law and facts as well as the joint discussions among students to improve their skills expository and argumentative.

1. Training activity: lectures and systematization by the Professor.
