The methodology followed in this course is oriented towards the achievement of the learning objectives. A wide range of teaching and learning tasks are implemented, such as theory sessions, practice sessions, problem-solving tasks, tutorials, autonomous work, and assessment tasks.

4.2.Learning tasks

This 12 ECTS course is organized as follows:

• Theory sessions (75 hours). Fundamental concepts of the course topics will be explained by the teacher.

- Practice sessions (45 hours). Two kind of activities will be used:
 - o Activities to learn theoretical concepts with the active participation of the students because they will apply their acquired knowledge to the understanding of new concepts.
 - o Problem-solving tasks.
- **Tutorials** (15 hours). They allow a more direct and personal support to students in order to answer questions about the course contents and guide them in their study and in the resolution of exercises. These tutorials may be individual or in a group.
- Autonomous work and study (153 hours). It consists on the preparation of theoretical and practical assignments as well as the study of the course contents.
- Assessment tasks and exam (12 hours).
