4. Methodology, learning tasks, syllabus and resources

4.1. Methodological overview

The methodology followed in this course is oriented towards the achievement of the learning objectives. It pursues that the student is a partner in the learning process, motivating the constancy and behavior of being in a continuous formative process. So the methodology combines, on the one hand, the face-to-face system in the classroom (with theoretical classes together with practical teaching based on the case model, exposure and debate by the students) and, on the other, the system of guided and independent work by the student that takes place outside the classroom.

4.2.Learning tasks

The course includes the following learning tasks:

- Lectores. Expository activities and systematization of knowledge by the professor. This kind of classes provide students with a theoretical first contact with the concepts and basic knowledge of the subject that will allow him, later, to carry out a more effective personal work and, in the end, a better learning of the subject, being able to train him for a more clear identification of the problems related to the Aragonese civil law matters and to try to design the ways of legal solution to them.
- Practice sessions. Practical teaching based on model cases, exhibition and debate of the students. These activities promotes intervention of the students in the classroom, it is facilitated to develop the capacity to identify and

analyze the legal problems, as well as its critical sense and its skill for the oral presentation making use of the technical-juridical language of the subject. These activities may also consist of the study and analysis of judgments, the preparation of legal documents or the holding of seminars of diverse content.
