- Topic 7. Models of presentation of the Archaeological Historical Heritage recovered: museums, interpretation centres, archaeological parks, cultural parks, etc. Examples.
- Topic 8. The dissemination of Archaeological Heritage: publications, websites, social networks, conferences, courses, etc. Examples.
- Topic 9. Cultural Heritage and society: management and social function. Integral management models. Cultural
  policy and social use of Cultural Heritage. Policy and Archaeological Heritage. Economic dimensions of
  Archaeological Heritage.
- Topic 10. Cultural tourism and recovery of Archaeological Historical Heritage.
- Topic 11. Professions related to Cultural Heritage and its management.
